Section 3 – External Auditor Report and Certificate 2019/20

In respect of **Ingatestone and Fryerning Parish Council – EX0131**

1 Respective responsibilities of the body and the auditor

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2019/20

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

The Internal Auditor's response to Objective L is not consistent with the information in Section 1, Assertion 4 and the prior year external auditor report. The Internal Auditor has confirmed no evidence has been obtained regarding the public rights period provided for during 2019/20.

The AGAR was not accurately completed before submission for review. The AGAR had to be sent back for amendment.
