	<ul> <li>Cllr Jeater reported that the BBC appointed surveyor will be visiting Seymour Field and Pavilion to provide a valuation this week. Once the report was received by the council, it will be shared with councillors.</li> <li>The Clerk advised the committee that she had received a reply from Cllr Wagland regarding the streetlight on Footpath 38 advising that no additional lights can be installed and that the existing lights are all working.</li> <li>The Clerk reported that Cllr Wagland had inspected the trees on Fairfield that are ECC responsibility and that they agreed works needed to be done but there was no further update at this time.</li> <li>Cllr Jeater asked if it is possible for BBC to cut the verges in the parish and it was concluded that this would be unlikely as they have a schedule of cuts which would be difficult to change.</li> </ul>

She advised that she would be seeking grant funding for some or all of the works but felt it important that an amount of £3000 be included in next years budget for this works.</li> <li>The committee was asked to submit other projects for the budget for next year. It was noted that the 'path of desire' at the Bellmead Community Centre should be included. It was also noted that the grounds maintenance contract and a possible separate gardening contract will be up for tender next year.
